



E-Safety Policy

Introduction

At Al Madinah Online Secondary School, we are committed to providing a safe and secure digital learning environment for all students. As an online school, we recognize the importance of e-safety to protect students from the potential risks associated with technology, while also enabling them to benefit from online education.
